LANCASHIRE CROSS COUNTRY TEAM SELECTION

The first 6 finishers in the following races will qualify for automatic selection for the Inter Counties team to run at Prestwold Hall, Loughborough in March.

- U13 Boys & Girls, U15 Boys & Girls, U17 Men & Women with 2 other places to be decided at team manager's discretion.
- Senior Men & Women with 3 other places to be decided at team manager's discretion.

The first 3 finishers in the U20 Men's and Women's races will also have automatic selection with 4 other places to be decided at team manager's discretion. U20s seeking selection must be under 20 for the whole of the competition year i.e. age at midnight December 31st 2024

An entrant shall be deemed to have made him/herself familiar with, and agreed to be bound by the UKA Anti-Doping Rules and to submit to the authority of UK Anti-Doping in the application and enforcement of the Anti-Doping Rules.

The UKA Anti-Doping Rules apply to entrants participating in the sport of Athletics, for 12 months from the (date of entry), whether or not the licence holder is a citizen of, or resident, in the UK.
